On charges of NO DRIVER LICENSE or FAIL TO MAINTAIN PROOF OF FINANCIAL RESPONSIBILITY, charges will be dismissed, if on or before the appearance date on the ticket you present to the Court a Driver License or Proof of Financial Responsibility that was valid at the time the ticket was issued.

PERSONS 16 YEARS OF AGE OR YOUNGER MUST APPEAR IN COURT
ACCOMPANIED BY PARENT OR GUARDIAN.

Charges of EXPIRED DRIVERS LICENSE and EXPIRED REGISTRATION can be dismissed, with proof that the violation has been corrected by the appearance date or within twenty (20) working days with a \$20.00 dismissal fee and proof the penalty was paid (on registration) when corrected.

Charges of EXPIRED INSPECTION CERTIFICATION will be dismissed, provided the inspection certificate was not expired for more than 60 days, and with proof that the violation has been corrected by the appearance date or within twenty (20) working days with a \$20.00 dismissal fee.
