ALL PERSONS 16 YEARS OF AGE OR UNDER MUST BE ACCOMPANIED BY A PARENT OR LEGAL GUARDIAN, IN THE EVENT OF AN ALCOHOL OR TOBACCO RELATED OFFENSE, ALL PERSONS 17 YEARS OF AGE OR UNDER MUST BE ACCOMPANIED BY A PARENT OR LEGAL GUARDIAN.

This form is furnished as a courtesy to assist you in making disposition of your traffic ticket. You may **APPEAR IN PERSON** or you may use this form and **APPEAR BY MAIL**. To appear by mail complete one of the options listed and mail this form to the court.

**MAKE REMITTANCE BY CASHIER'S CHECK OR MONEY ORDER (PERSONAL CHECKS WILL NOT BE ACCEPTED)** to the court address on reverse side. Return your copy of the citation and this letter with your remittance to assure proper credit. **A telephone call does not constitute an appearance and will not prevent an issuance of a warrant.**

## **IF YOU HOLD A COMMERCIAL DRIVER LICENSE YOU CAN NOT TAKE A DRIVING SAFETY COURSE OR REQUEST DEFERRED ADJUDICATION BY TEXAS LAW.**

OR

I hereby enter a plea of nolo contendere (no contest), waive my right to Jury trial, and request that the court defer proceedings 90 days and allow me to complete an approved driving safety course. I have a valid TEXAS DRIVING LICENSE. I have not completed a driving safety course within the last 12 months nor have I completed one not yet reflected on my driving record. I will submit to the court proof of financial responsibility (insurance on self). My ticket is not for speeding 25 M.P.H. or more over the speed limit. I understand that this form must be NOTARIZED and sent to the court by mail, along with a copy of Driver's License and copy of insurance on or before the appearance date on the ticket to be eligible for a driving safety course.

I will pay all court costs and fees provided by law.

I further understand that this form **MUST** be signed, notarized, and submitted to the appropriate **Municipal Court with the \$129.10** cost and a self addressed, stamped envelope by the appearance date on my citation to be eligible for a Driving Safety Course
